Road-map to Licensure

ELAR - The Educator Licensure And Renewal (ELAR) portal is the comprehensive online licensure application system. It enables licensure applicants to create and access their personal profile as well as submit and pay for license and endorsement applications online, and renew licenses and endorsements online. Everyone must create an ELAR account to apply for any license.

Preliminary License -

Preliminary Vocational Technical Teacher license — valid for 5 years of employment. Requirements for a Preliminary Vocational Technical Teacher license:

1. Depending on the field applied for, the license will require one of the following:

- a. Possession of a High School Diploma/GED equivalent
- b. Possession of an Associate degree in the subject matter knowledge and skills to be taught
- c. Possession of a Bachelor's degree in the subject matter knowledge and skills to be taught
- 2. Documentation of the required years of employment experience in the field of the license
- 3. For certain fields, possession of a state or national occupational license or certification is required
- 4. Achieving a passing score of at least 70 percent on both the written and the performance vocational subject matter test
- 5. Achieving a passing score on one of the following Massachusetts Tests for Educator Licensure (MTELs):
 - a. The Vocational Technical Literacy Skills Test (VTLST)
 - b. The Communication and Literacy Skills Test

Professional License - Requirements to advance a Preliminary License to a Professional license:

- 1. At least 3 years of employment under the corresponding and valid Preliminary Vocational Teacher license
- 2. Completion of a school district-sponsored one-year induction program
- 3. For licenses that require an occupational license or certification, you must maintain such a license/certification
- 4. Completion of 18 college credits in vocational education courses approved by DESE
- 5. One of the following:
 - a. Possession of a Bachelor's degree
 - b. 18 academic college credits in academic coursework as follows: 3 credits in English, 3 credits in mathematics, 3 credits in science and 9 additional credits in English, math, science or coursework related to the vocational technical education subject
 - c. Possession of a higher degree than the one required to obtain the corresponding license at the Preliminary stage

MEPID - Massachusetts Education Personnel ID (MEPID) number for you. The MEPID is a unique identifier assigned to all educators and to school district staff in Massachusetts. A MEPID will be assigned to anyone who creates a profile in ELAR. Once an applicant creates a profile, their MEPID can be found in the Personal Information section on the Inquiry Activity.

Vocabulary & Definitions

VTEL - The Vocational Technical Literacy Skills test is an example of Massachusetts Tests for Educator Licensure, commonly referred to as MTELs. The test measures the applicant's ability to read and write in English and are made up of a reading and a writing subtest. Applicants must take and pass both subtests in order to achieve an overall passing score. These test scores are automatically submitted to the ELAR system a few weeks after the exam date.

Chapter 74 Programs - Chapter 74 - approved vocational technical education programs that meet the definition of vocational technical education contained in Massachusetts General Law Chapter 74, and are approved by the Department of Elementary and Secondary Education pursuant to Chapter 74 and the Vocational Technical Education Regulations. Note that all Chapter 74 - approved Vocational Technical Education programs meet the federal Perkins Act definition of Career and Technical Education. These programs have a minimum of 900 program hours.

Professional Development (PD) - Professional Development is a set of coherent learning experiences that is systematic, purposeful, and structured over a sustained period of time with the goal of improving teacher practice and student outcomes.

Chapter 74 State Frameworks - This Framework includes standards that are representative of all aspects of the industries that students enrolled in Chapter 74 state-approved Vocational Technical Education Programs are preparing to enter. This vocational technical framework reflects the size, scope, and quality of Chapter 74 state-approved Vocational Technical Education Programs in Massachusetts. These are made up of six strands: Safety and Health Knowledge and Skills, Technical Knowledge and Skills, Employability, Management and Entrepreneurship Knowledge and Skills and Technological Knowledge and Skills. Licensure

Completion of the Six Professional Education Courses

In order to be awarded a Professional Vocational license, educators must complete six 3 credit professional education courses and SEI approved by the Department of Elementary and Secondary Education. These courses address various pedagogical techniques for working in Vocational Technical Education. These courses are offered at Fitchburg State University, Westfield State University and through the Massachusetts Association of Vocational Administers (MAVA). The courses may be taken in any order. Educators should contact the university to see which courses are being offered in a given semester.

Six - 3 credit Occupational Education Courses Required for the Professional Vocational Teacher License

Seminar of the Beginning Vocational Technical Education Teacher (3 credits)

Teaching Methods for Vocational Technical Education - Instructional Strategies (3 credits)

Address the Needs of Students with Disabilities in Vocational Technical Education (3 credits)

Teaching Methods for Vocational Technical Education - Educating and Assessing the Vocational Education Learner (3 credits)

Developing and Implementing a Standards-Based Curriculum in Vocational Technical Education (3 credits)

Teaching Methods for Vocational Technical Education - Using Research-based Practices to Develop Effective Instructional Strategies (3 credits)

After completing the courses, educators should submit an official college transcript documenting that they were awarded college credit for completing the courses: an official college transcript will bear the signature of the registrar.

Obtaining the Sheltered English Immersion (SEI) Endorsement is a requirement for the Professional license.

Course Work

Educators have 3 ways for completing the core academic coursework for the Professional license. These courses may be obtained at any accredited community, two or four year college.

Therefore: - If a high school diploma/GED equivalent was required to earn the Preliminary license, an applicant <u>may</u> fulfill this requirement by possession of an Associate degree from an accredited university - If an Associate degree was required for the Preliminary license, an applicant <u>may</u> fulfill this requirement by possession of bachelor's degree for an accredited university

Testing

Professional Development Purpose: The Massachusetts license renewal system will enhance education through ongoing professional development for educators that meets high standards for quality. The license renewal system is carried out in the context of professional development for school improvement leading to increased student learning. The goal is for educators within a school and district to work together so that license renewal achieves educational goals for the individual, the school, and the district, in order to assist students in meeting state learning standards.

Professional Vocational Technical Teacher License - renewed every 5 calendar years:

Career and vocational technical education teachers in possession of a Preliminary license, who wish to know where they stand in terms of the requirements for advancement, are encouraged to submit an application for the Professional license. This will prompt a review of the educator's file to see what requirements have been met.

Professional development activities shall be identified by the educator and supervisor during the development of, and review of, the Individual Professional Development Plan (IPDP)* in order to better support student achievement. Individual professional development plans must include at least 150 PDPs that break down as follows:

At least 15 PDPs in content (subject matter knowledge)

At least 15 PDPs in pedagogy (professional skills and knowledge)

At least 15 PDPs related to Sheltered English Immersion (SEI) or English as a Second Language (ESL) At least 15 PDPs related to training in strategies for effective schooling for students with disabilities and the instruction of students with diverse learning styles

The remaining required 90 PDPs may be earned through either "elective" activities that address other educational issues and topics that improve student learning, or additional content, and/or pedagogy.

Sheltered English Immersion Endorsements (SEI)

Background: English Language Learners (ELLs) are an important focus of the Massachusetts Board of Elementary and Secondary Education's (BESE) Proficiency Gap Task Force. Closing the proficiency gap depends on teachers having the skills and knowledge necessary to instruct ELLs. Sheltered English Immersion (SEI) is an approach to teaching academic content in English to ELLs. Generally, but not always, ELLs are in the same classrooms as native English-speaking students. To better serve these students, core academic teachers, vocational teachers and those administrators who supervise and evaluate core academic teachers are required to obtain an SEI teacher or SEI administrator endorsement.

Who Must Hold the Endorsement?

Core Academic Teachers (early childhood, elementary, teachers of students with moderate and severe disabilities, English, reading, language arts, mathematics, science, civics and government, economics, history, and geography) Academic Administrators (principal/assistant principal or supervisor/director only)

Vocational Educators applying for their first Professional Vocational license or certain Initial Vocational Administrator licenses (specifically Vocational Principal/Assistant Principal and Vocational Supervisor/Director) must obtain the SEI endorsement.
